Bare land strata and air space parcels are just two of the dynamic aspects of strata corporations that require strata and the insurance industry to adapt. Our panel will provide a broker, legal, and consumer perspective on key topics changing within the strata industry: bare land strata, deductibles and chargebacks, air space parcels, and earthquake coverage.

- Identify earthquake coverage types, geographical and geological regions, and their impact on strata corporations
- Review strata earthquake coverage policy definitions, exclusions, exemptions and the potential implications
