Each presentation must comply with these terms and conditions ("Terms & Conditions"). This is a skill-based challenge, and chance plays no part in the determination of the Challenge winner. Void where prohibited or restricted by law.

By entering this Challenge, including submitting a link via email to your presentation to RI, you ("you," "your") agree to be bound by and accept, without limitation or qualification, these Terms & Conditions and all terms, policies, guidelines, or other notices incorporated herein by reference. If you do not agree to these Terms & Conditions, do not submit a presentation to RI. By submitting a presentation to RI, you represent and warrant that you are at least eighteen (18) years of age and are lawfully able to accept these Terms & Conditions.

Please note that RI will only communicate with you electronically or via email. Links to presentations received after 27 May 2013 will not be considered during RI's winner selection process.

### Presentation Requirements:

- Create a video using any of the following presentation styles: PechaKucha, Lightning Talk, or Ignite (you must obtain any required licenses to use PechaKucha, Lightning Talk, or Ignite and RI will not provide you with any such licenses)
- Upload your presentation to your YouTube or Vimeo Account
- Email RI: 1) the link to your presentation on YouTube or Vimeo page and 2) your full name, contact information, and Rotary affiliation
- The presentation must not exceed seven (7) minutes in length
- The presentation must be in English or contain English subtitles

## Presentation Restrictions:

- The presentation shall not contain any of the following:
  - Music, photographs, artwork, videos and footage owned by others
  - Images or likenesses of others
  - o Trademarks or logos owned by others

Your presentation shall not be or contain materials that are inappropriate, indecent, discriminatory or obscene, as determined in RI's sole discretion, or contain unlawful, infringing or illegal materials. You may not submit a presentation to RI that violates or infringes on the rights of others, including, but not limited to, privacy, publicity, tort, copyright, trademark or patent rights. You may be required to show proof that you are the creator of or have permission to submit the presentation to RI and that you are the person appearing in the presentation.

**Presentation Selection:** A panel of three judges determined by RI, in its sole discretion, will select six winners from among all eligible presentations based on the following criteria: 1) Focus to purpose of Challenge (50%); 2) Originality/Creativity of presentation (25%); and 3) Quality of presentation (25%). The six winners of the Challenge will be notified on or around 31 May 2013. The judges' decision is final.
