Via NJ Turnpike

Exit Turnpike at Exit 9 (New Brunswick). Bear right onto Route 18 North. On Route 18 stay in left lane approximately three miles. Exit Route 18 for Route 27 South (towards Princeton). Loop under Route 18 and at second light make a left. Hotel is on the left hand side.
